

In 1944, the Italian mountain village Sant' Anna was wiped out by a German SS-division




The italian authorities assume alltogether 560 deaths. Including at least 107 children in the age of up to 14 years, 29 persons in the age of 15 to 18 years and 11 persons the sixties.

Nazi SS troops went door to door and massacred 218 Greek civilians. Survivors said that the nazist forces "bayoneted babies in their cribs, stabbed pregnant women, and beheaded the village priest...



The massacre of Distomo is regarded as one of the most atrocious and barbaric actions of WW2.

Yet, the German Federal Constitutional Court and the International Court of Justice have ruled that Germany should not pay any compensation for that crime.

II.

The German Democratic Republic, the first socialist nation on German soil, a state of international friendship and peace, was annexed, plundered, and pauperized by German Imperialism. "...The Signatory States agree that a major goal of their common policy is one between Germany and its former enemies freely negotiated peace settlement for Germany, which is to form the basis for a lasting peace..."

The GDR was a nation of peace and international friendship




On the basis of a cross-national agreement the GDR lead the "Hospital Carlos Marx" from 1985 till 1990 in Managua in Nicaragua.

There up to 100 people from the GDR (medical doctors, nurses, technicians, interpreters) were working together with ca. 400 Nicaraguan employees.

With great effort medication and materials - from tap to X-ray apparatus - were delivered from the GDR and in this way a "county hospital of the GDR on Nicaraguan ground" was built up and supported.

More than 20% of the GDR population had to leave their homeland since 1990 in search for work No youth - No future

Head of the German Federal Bank, Jens Weidmann:

" It seems to me that in Germany there is a lot more receptiveness to the surrender of national sovereignty than in many partner countries.

In order to establish a stability orientated fiscal union, it is my firm opinion that it is mandatory for EU countries to offer two things:

First the willingness to submit to strict budget rules. Secondly the willingness to surrender parts of their national sovereignty to a central level, which can effectively control and enforce the compliance of the rules. "

KEY FINDINGS:

Red Cross and Red Crescent Societies

- The crisis has increased the number of people living in poverty.
- The gap between rich and poor is increasing.
- More people are asking for food aid as well as other kinds of assistance.
- The humanitarian impact of the crisis is being felt well beyond any economic upturn.

"There are now more than 18 million people receiving EU-funded food aid, 43 million who do not get enough to eat each day and 120 million at risk of poverty in the countries covered by Furostat.

And while we still hope the crisis will end soon, for many it has just begun. Or is just about to begin."

The German army progressively brings parts of other European armies under its command.

In May 2013, it commanded vast parts of the Dutch army and the Polish marines.

The European countries were forced by the Lisbon Treaty of 2009 to enlarge their military. This treaty was mainly written by German Imperialism.

Not even the economic rule over Europe by German Imperialism can be maintained by peaceful means any longer.



The peoples of Europe are starting to resist against their pauperisation.
